The PI Committee, however, may decide the issue is not appropriate for system discussion and recommend it be managed internally at your facility or agency. - 1. Please fill out the attached Regional Performance Improvement Case Review Request Form.
- 2. Email an encrypted form to Pl@strac.org. If you do not have the ability to encrypt the message, FAX with a cover sheet to (210) 233-5822.
- 3. Please include your contact information to ensure we can reach you for any questions about the submission.

What happens to my submission?

- 1. Once your request has been received, you will receive confirmation within one business day from the STRAC PI Committee Project Coordinator or their representative that your submission is being processed.
- 2. Your request will be forwarded to the appropriate Committee Chair (Behavioral Health, Cardiac, Stroke, or Trauma as applicable), Co-Chair, and the STRAC Executive Director for review.
- 3. The Committee Chair (Behavioral Health, ED-Ops, Cardiac, Stroke, or Trauma as applicable), Co-Chair, and STRAC Executive Director will make the determination if the case warrants presentation at PI (Behavioral Health, ED-Ops, Cardiac, Stroke, or Trauma as applicable) Committee.
- **4.** All parties involved will be notified.
- 5. If the case will be reviewed at the respective PI Committee, STRAC will compile any associated documents and/or recordings necessary to provide to the respective PI Committee.
- **6.** All parties will be notified when the case is up for review and invited to the meeting.
- 7. A report of the discussion and results/outcomes of the review will be provided to the committee membership.
